

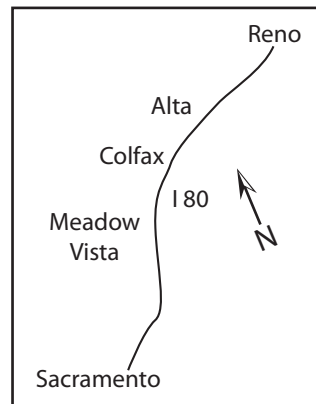

Helps the many small Placer County communities from Applegate to Donner Summit thrive. The Chamber's membership is a diverse sampling from every type of business and civic interest.

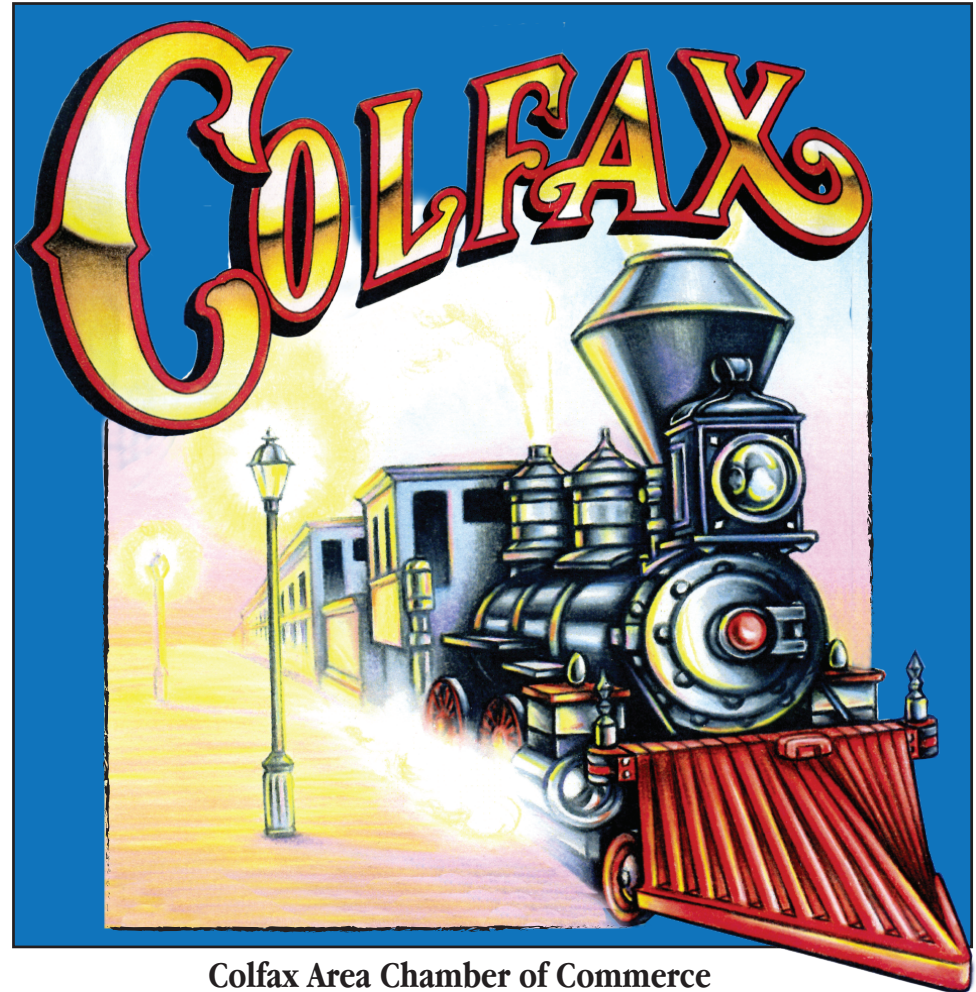
