## Cannabis Business Application Continued To February 24 Meeting

Of the two city council meetings held in January, the second one certainly garnered the most public interest. Cannabis was back on the agenda, prompting nearly 30 people to e-mail, text or phone in their comments during the meeting.

The question before the council was whether or not to approve a resolution authorizing the city manager to issue a commercial cannabis cultivation business

permit valid for one year to Fireworx Farms, LLC. The application from Fireworx was the only one received by the city during the application period that ran from September 25 to November 24.

The Fireworx application details a proposed growing operation that would feature eight, 2,500 square-foot, fully enclosed greenhouses, and that would hire 18-20 full-time employees from Colfax and Placer County starting at \$17/hr. The estimated

annual tax revenue from the operation would add \$140,000 in unrestricted funds to the city's general fund.

The application before the council had been previously vetted and scored by SCI Consulting Group, based on the nine criteria established by city ordinance. Those criteria included:

- the qualifications of owners and managers

## The Mask Lady



Anna Anderson took her first box of homemade, cloth face-masks to the Colfax Post Office on a Tuesday morning in late summer 2020. On Friday the Postal clerk called hoping to get more masks because the first batch was all gone.

Anna's masks come individually packaged, made from fabric of varying colors and designs, and are engineered with a metal nose wire for a tighter fit. Best of all, they're free.

"And they all have a card inside that says to wash the

mask before wearing it," she said. "It's always better to be safe."

The design she uses, called an 'Olson' mask, is one she found on the Internet. "It has a pocket on the inside so that the wearer can add extra protection if they want to," she said.

The material comes from remnants ('fat quarters') that she

finds in fabric stores and thrift shops and people, who support what Anna is doing donate some as well.

Anna started making masks for friends and family in March 2020, when masks were generally in short supply. She rapidly built up an over supply and decided to begin giving them away at the Post Office, and at the Creative Corner gift shop in downtown Colfax.

After nearly a year producing them, she's made close to 800 masks and intends to keep on going, as long as masks are needed for public safety.

"Giving them away instead of selling them is my way of contributing to the COVID war effort, by encouraging people to wear a mask," Anna said. "It also gives me something to do and makes me feel like I have a purpose."

**Update From Supervisor  
Cindy Gustafson**

As you can imagine many people are calling, writing and emailing in search of more information on when they can get vaccinated. I understand that this is an extremely frustrating time for all of us – so I am hoping to help explain what we know and, just as importantly, what we don't know. Information changes rapidly, but here is where we stand as of 1/25/2021.

The limitations on vaccine availability are entirely due to limitations on the supply of doses. Placer has been allocated an average of 4,343 doses of the Covid-19 vaccination (first and second) per week. To give you an idea on how far that goes, there are approximately 80,000 Placer residents who are 65 or older - not to mention the thousands of healthcare workers and others that fall into the Phase 1a category as well.

At this pace, it would take us four-to-six months to vaccinate our most vulnerable and our essential workers. We do know that

### Main Street Pizza: "Thanks for your support."

**Basement Wines & Main Street Pizza** is right downtown on, of all places, Main street, 46 North Main, to be exact. Right next door to another of my favorites, Grandma C's Kitchen.

In addition to the wines and pizzas mentioned in the name, what else will you find there? How's this sound: 20 beers on tap, sandwiches, appetizers and more. Beers include local craft beers, ciders and old favorites like Coors Light.

As for the wines, they have a wide variety of wines from near and far, including their signature wine made in Colfax, Two Monsters. The label on the wine bottle suggests the name of the wine, Two Monsters, was inspired by their two sons! Their first release was in 2009, and the 2012 release includes a delightful, well-balanced Petite Sirah, plus a Barbera/Petite Sirah.

Owners Lee and Laurie Shahin wanted to have a business, so in 2003 they opened Basement Wines on south Main Street. In 2009 they opened Main Street Pizza on north Main. For a couple years, they tried bringing pizzas from the

more vaccine is on the way and we are actively fighting to secure as much as we can for our residents. As soon as we get it - we get it out. Unfortunately none of us believe this is fast enough.

Placer County does have capacity to give the vaccines once we receive more doses. Placer County Public Health and Safeway alone currently have the capability to administer around 7,400 per week and other health providers throughout the county have the capacity to administer thousands more. Also, Public Health continues to cultivate partnerships with other pharmacies to further expand capacity as we receive more vaccines.

As we see additional doses become available, more appointments for vaccines will also be available to community members. One of the best ways to be notified when large new batches of appointments are made available at county clinics and about progression through the vac-

ination phases is to sign up for text alerts. To do that, **text PLACERVACCINE to the number 898211.**

I know this is a challenging time, but please be patient and have confidence that more vaccines are coming. I encourage you to sign up for text alerts and to continue to check the Website, and I will also continue to update you through newsletters as we have more information to share.

Finally, a reminder to all of us – whether we’ve received the vaccine or not – please continue to work together and follow safety protocols.

## Slightly Fewer Colfax Volunteer Fire Department Incident Dispatches in 2020

The Grass Valley Emergency Command Center (GVECC) dispatched 31,533 incidents in 2020, a decrease of 550 incidents a percentage of 1.71% from 2019 which had 32,083 incidents.

- In 2020 Colfax Vol FD was dispatched a total of 624 times – 329 times in the City and 295 times outside of the City.
- In 2019 Colfax Vol FD was dispatched 650 times total – 325 in the City and 325 outside of the City.
- There was a difference of 26 fewer incident dispatches in 2020 than 2019, a 4.2% decrease. There were four more dispatches in the City, but 30 fewer outside of the City.
- The three-year average shows 323 incidents

- plans and location
- a business plan
- operations plan
- safety plan
- security plan
- neighborhood compatibility plan
- community benefits plan
- labor and employment plan

Those criteria also mandated that applicants must score a minimum of 80 percent to earn a public hearing on the application before the council. Fireworx scored 95.22 percent.

After hearing more public comment than usual following the Fireworx presentation and asking questions of their own, the council voted unanimously to continue the public hearing to the second meeting in February. Before that meeting council members will tour one of the other Fireworx growing operations in Sacramento on February 8. The date of the Continued hearing will be February 24.

**CARES Act** –The Coronavirus Aid, Relief, and Economic Security (CARES) Act was also back on the council agenda because additional funding has been made available to the state for allocation to counties and cities. Of the roughly \$130 million in additional funding Colfax would receive \$219,150.00. The money can be used for community development and/or economic development related to directly preventing, preparing for, or responding to COVID-19.

Before submitting an application, the city was required to hold a public hearing to gather information regarding the needs of the community and business community. Staff will then work to prepare the final application for approval at a future meeting. The deadline for the submittal is on a rolling due date beginning February 12, 2021.

**CalFIRE Contract** –The final piece of business was establishing an Ad Hoc committee to review the current Placer County/CalFIRE contract and recommend changes. When all five members expressed a desire to sit on the committee that approach was scrapped in favor of holding a public workshop with all council members in

attendance on a future date. The current Placer County/CalFIRE contract is scheduled to expire June 30, 2021.

**At its January 13 meeting** the council heard a proposal from Colfax High School student Griffin Vernon to build a mountain biking complex at the old city landfill site on Iowa Hill Rd.

Vernon laid out an ambitious concept for mountain bike venue that he estimated would cost between \$20,000 and \$40,000, and be built in three phases depending on funding and community involvement. He said funding would largely come from donations.

Following Vernon's presentation and comments from the council, the city manager reminded everyone that the old landfill site is regulated by state and county agencies. He said that their approval on the concept would be required before any further steps could be taken and that approval wasn't assured.

Council members also questioned if a bike park was the best use for the property, as well as concerns that fundraising for a bike park might hamper fundraising for the skate park proposed for the city's old pool site.

A subcommittee was formed to investigate the proposal further.


## Western Monarch Butterfly Population In Severe Decline

During its annual winter survey of Western Monarch butterflies in 2020, the non-profit Xerces Society counted 29,000 of the orange and black insects. That was considered a hopeful sign after the winter survey in 2019 found an all-time low of 27,000.

**This year's annual survey could only find some 2,000 Western Monarchs in their usual overwintering grounds along the central and southern California coast.**

The steep decline in Monarch population numbers is attributed to continued loss of the butterfly's milkweed breeding habitat to agriculture and urban development, as well as the accelerating climate change that is producing larger and more de-

structive wildfires along western coastal areas.

Monarchs all but disappeared here in the western Sierra Foothills following the punishing 2016-17 wet season, when mul-

tipale 'atmospheric river' storms blasted California coastal areas.

Washington State University researchers predicted in 2017 that Monarchs would likely be extinct in the very near future if nothing were done to reverse population declines.

Monarchs have neither state nor federal protection to prevent their critical breeding habitat from being destroyed. In December 2020 the butterfly became a candidate for threatened or endangered status, but federal officials declined to take immediate action to list it as such.
